Question N° 4:

On the point 3 "The proposal" is mentioned the following requirements for the submission of; the EOI? or the proposal after the RFP?

- The company experience and background regarding the construction operation and maintenance of oil & gas facilities
- The preliminary engineering, detail technical information regarding the construction of LNG terminal & port facilities – connection pipeline and auxiliary installations (off-shore and on-shore)

- Preliminary project financing structure proposal.
- Estimated schedule of the project

Response N° 4:

Enarsa is looking for expressions of interest regarding the project. At this stage, an introduction of the company (Company experience, and background regarding the construction operation and maintenance of oil & gas facilities), and the capability of financing the project, will be enough to have you on the next stage. For the RFP, more technical information will be provided.

Question N° 5:

Although they will offer to share some information once the RFP is issued (February 2017) there is a very short time until the selection of the awarded bidder (March 2017), so I believe they are not expecting a very comprehensive or binding proposal. I would want to know more in detail the scope of proposal that they will be expecting

Question N° 6:

Would you have any information available regarding the seawater temperature at or around the proposed site? NB: Ideally it would be a data series over a few years but at least per month.

Please find attached the average for the last 4 years seawater temperature.

Question N° 7:

What seawater differential will be mandate between the temperature in the water and temperature of water returned to the sea as part of an open loop process?
NB: The World Bank guideline is 7 degrees Celsius but we understand Argentina projects may not require thus impacting the overall fuel warranties.

Response N° 7:

Please take 7 degrees Celsius. This will be confirmed with the feasibility study.

Question N° 8:

Could you please clarify the water depth where LNG terminal and the pipeline locate?

Response N° 8:

Depth; 13.70 mts (aprox 44 feet).

Pipeline Located; estimative 30kms fm Punta Alta facilities.
